परिपत्र CIRCULAR

Subject: Declaration of COVID-19 as Medical emergency under Rule- 15 of CHSS Rules, 1998 – Reimbursement of medical expenses – Reg.

\*\*\*\*\*

There is a drastic spread of COVID – 19 pandemic in the State of Telangana, especially in GHMC, Ranga Reddy and Medchal-Malkajgiri Districts, wherein 85% of the total cases of State of Telangana are being reported. Thus to avoid any hardship to the CHSS beneficiaries in getting immediate medical treatment for COVID-19 positive, Competent Authority has declared treatment of COVID-19 as medical emergency under Rule-15 of CHSS Rules, 1998.

2. In this regard, CHSS beneficiaries in Hyderabad can now avail treatment directly from the Private Hospitals which have been authorized by the Government of Telangana for treatment of COVID-19. List of Hospitals authorized by the Government of Telangana, as on date is enclosed in the Annexure for reference. Rates fixed for treatment of COVID-19 by Health Medical and Family welfare Department, Government of Telangana vide G.O.No.248 dt.15.06.2020 will be reimbursable subject to the ceiling amount or bill amount whichever is less, subject to the following conditions :

- a) Those CHSS beneficiaries who do not get treatment from CHSS empanelled Hospitals due to non-availability of beds, etc may avail treatment only at authorized Private Hospitals approved by the Government of Telangana.
- b) Intimation on availing of the COVID-19 treatment as at (a) above is to be furnished within 02 days from the date of commencement of the treatment to CMS(CHC & CHSS).
- c) Claim for reimbursement shall be submitted to CMS (CHC & CHSS) along with all original bills / receipts together with a certificate from the concerned Private Hospitals on the COVID – 19 treatment provided to the CHSS beneficiaries for consideration.
- d) Retired employees and enrolled under CHSS shall submit their Bank details along with IFSC code at the time of claiming reimbursement.
- e) Reimbursement of the claim will be restricted as per rates fixed by the Government of Telangana vide GO.No.248 dated 15.06.2020 or bill amount whichever is less. Wherever, Government of Telangana has not fixed the rate for any items, the rate fixed by NFC for such items will be applicable. **Difference in the cost of treatment between the rate fixed by Government of Telangana and NFC for various procedures, will have to be borne by the beneficiary himself/herself.**

- f) As regards the admissibility of additional charge for PPE Kit is concerned, competent authority has agreed for reimbursing an amount of Rs. 3,000/- (Rupees three thousand only) towards PPE Kits per day/per patient for those CHSS beneficiaries who get admitted as a in-patient. Similarly maximum amount of Rs. 500/- (Rupees five hundred only) will be admissible for each Out-patient visit.
3. All beneficiaries of CHSS are requested to note the above.
