CIRCULAR

Reference is invited to Circular No. NFC/CHSS/04/01/2020/1564 dt. 27.01.2020 as per which submission of acknowledgement of the latest Income Tax Return was compulsory in respect of dependent Parents/Parents-in-law (in case of female employees).

2. Based on the various representations received from NFCIWU, NUFLOSSA and NUFCSAA requesting for exemption from submission of ITR acknowledgment for establishing dependency to extend CHSS facilities to the parents and parents-in-law (in case of female Govt. employees) of the employees, the matter was referred to DAE for relaxing the above mentioned condition, as a special case for the current year i.e. 01.04.2020 to 31.03.2021, with the approval of Chief Executive, NFC. However, DAE has not agreed to the above request of NFC.

3. Consequently, it is decided to deactivate the validity of CHSS cards with immediate effect in respect of dependent parents and parents-in-law (in case of female Govt. employees) of such employees who have failed to submit the acknowledgment from Income Tax Department for having filed the IT Returns.

4. In view reply received from the Department, no further correspondence will be entertained in this matter.
