विषय : सीएचएसएस, एनएफसी, हैदराबाद के तहत लाभार्थियों के अंगूठे के निशान (दाएं एवं बाएं) दर्ज करने – संबंधी

Sub: Capturing of thumb impressions (Right & Left) of beneficiaries under CHSS, NFC, Hyderabad – reg.

Reference is invited to this Office Circular No. NFC/Admn./CHSS/01/2021/632 dated 01.11.2021 informing CHSS beneficiaries about extending the exercise of capturing thumb impression at NFC for a period of 02 Months i.e., from 01.11.2021 to 31.12.2021.

2. As per the said circular, the last date for completion of the exercise was 31.12.2021. However, inspite of extending the said arrangement multiple times, it is noticed that some of the CHSS beneficiaries has not registered their thumb impression till date.

3. Now that implementation of Hospital Information Management System (HIMS) is in the final stage, Competent Authority, NFC has accorded approval for arranging the exercise of capturing thumb impression at NFC, Hyderabad from 01.07.2022 to 15.07.2022, as a special case.

4. It may please be noted that CHSS services to those beneficiaries who have not registered their impressions on or before the said date will remain suspended till their finger print biometrics are recorded in HIMS. It is therefore requested to register their thumb impression at the venue mentioned below:
