Sub: Classification of entitlement of Hospital accommodation under CHSS

This has reference to the Agreement entered into with your hospital w.e.f. 01.03.2011 regarding empanelment of your hospital under CHSS facility of NFC. In this regard the entitlement for hospital accommodation to the CHSS beneficiaries is detailed below:

**1. (a) In respect of all Serving Employees and those Retired on or after 01.01.2006:**

**Note:** 'Pay' for this purpose is pay drawn in the pay band(PB.Pay).  
Grade pay is not to be reckoned as pay for the purpose of accommodation entitlement.

In the event of non-availability of entitled accommodation to our beneficiaries, at any time, the provisions mentioned at clause No.13 of the Agreement entered into with your hospital may scrupulously be followed to avoid any inconvenience to the CHSS beneficiaries..

As regards the details of pay drawn by a serving employee, he/she will be asked to produce a copy of pay slip at the time of admission. In respect of employees retired prior to 01.01.2006, their pre-revised pay has already been indicated on their CHSS cards. In respect of those employees who retired from 01.01.2006 to 31.10.2008, a statement indicating their revised pay is enclosed W.e.f. 01.11.2008, the details of last pay drawn by the retired employees has already been incorporated in their CHSS cards.
