

All CHSS beneficiaries covered under the medical scheme of NFC are requested to note the following guidelines, which were given to all Zonal / Super speciality Hospitals recognized under the CHS Scheme of NFC to extend medical treatment in emergency situation.

1. Emergency admissions required during the night / early hours requires no prior approval or payment by beneficiary. However, they are required to provide their identity followed by referral on the next working day.
2. Price limit for obtaining prior approval for carrying out investigations/administration of medicine has been raised from Rs. 1000/- to Rs. 2500/-. The approval can be given by any Medical officer who is in charge during working hours of Sanjivini or by any Medical officer on duty as per the roaster, after working hours.
3. Procedure and medicines required during inpatient treatment and surgeries exceeding the above limits need no prior approval of Medical officer, NFC. Hospitals will give the details of procedures / investigations / medicines after the surgery / treatment to CMS, OHC/CHC for information.
4. Mobile phone No.7093167300 has been provided to CMS and on duty Medical officer, he / she can be contacted in emergencies for obtaining permissions / approvals.
