Therefore, they are **required to produce all original certificates along with one set of Xerox copy of the following for verification:**
- Valid Identity proof such as Aadhar Card/PAN Card/Voter ID Card/Driving License/Passport;
 - Original certificates of education starting from SSC/X Standard onwards;
 - Caste certificate(SC/ST/OBC) issued by duly authorized authority;
 - Discharge certificate issued by appropriate authority in respect of ex-servicemen;
 - Experience certificate(s).
 - Valid Heavy Driving License, if any.
 - Candidates working in State/Central Government/Public Sector Undertaking/Autonomous bodies should produce original "NO OBJECTION CERTIFICATE" issued by the Competent Authority of the employer concerned for attending Certificate verification/Stage-2 Advance Test in NFC
- b) Verification of certificates is mandatory. Only those candidates whose certificates get verified will be allowed to attend Stage-2 Advance Test.
- c) Candidates are required to bring their own black ball point pen for marking the answers.
- d) Roll No. as allotted for Stage-1 Preliminary Test would be the same for Stage-2 Advance Test.
