Reference Stage-1 Preliminary (Screening) test for the post of **Stipendiary Trainee Category-I (Electronics - Post Code 21904)** held on 08.07.2021(FN) and list of candidates declared qualified as uploaded in NFC website on 21.08.2021. As per the selection procedure indicated in the advertisement, the candidates are required to undergo Physical Standard Test and to appear for Interview **scheduled during 23.09.2021 to 25.09.2021**. The candidates are required to bring the documents as per the instructions given in **Annexure-I** and report on the date and time mentioned in **Annexure – II. No request for change of Venue/Date/Time will be entertained.**

2. **Admit cards as issued for Stage-1 Preliminary (Screening) test will be valid and allowed for Physical Standard Test and Stage-2 Interview. No separate Admit card will be issued.**

3. The candidates may note that they are required to stay for two working days compulsorily i.e., the date of reporting and the following day (excluding Sunday) for Physical Standard Test and Interview. **Candidates are requested to make their own arrangement for Travel and Accommodation.**

4. Candidates are required to report at **Dr. Homi J. Bhabha Convention Center, ECIL X Road, ECIL Post, Hyderabad, Telangana – 500 062** on the scheduled date of reporting. Candidates can reach the venue by city bus and alight at ECIL x Road.

5. Outstation SC/ST candidates are eligible for payment of TA equivalent to second class Train Fare or bus fare by the shortest route from their place of residence. The candidates are required to produce copy of (i) certificate of Non-employment from MP/MLA/Gazetted Officer of the place where the candidate normally resides, (ii) original travel ticket/proof of travel and (iii) caste certificate for reimbursement of TA. The TA amount as admissible will be remitted into the Bank account of the candidate separately and no cash payment will be made.

6. While reporting for the Test/Interview, the candidates are required to download and print the 'Declaration Form' attached herewith (**Annexure – III**) and fill all the necessary details as mentioned in the form including pasting of passport size colour photograph at the appropriate place.

7. Select Panel will be displayed on a separate date on NFC website www.nfc.gov.in. Therefore, candidates are advised to visit NFC website from time to time.

8. **Canvassing in any form will be a disqualification.**

9. Candidates should follow Covid-19 norms like maintaining physical distance, wearing masks throughout the selection process, sanitization etc. Therefore, candidates without mask/face covers will not be allowed entry into the venue.

10. Candidates are requested to make note of the above schedule for making necessary arrangements by them for travel and stay.

ESSENTIAL REQUIREMENTS FOR ATTENDING INTERVIEW

1. **The candidates are required to bring original of any one of the valid Photo Identity Proof viz., Passport, Driving Licence, Aadhar Card, Voter Identity Card or PAN Card for Identity verification at Test centre.**
2. **The candidates are required to report with the following documents. Candidates who fail to submit the following documents will not be allowed to appear for Physical Standard Test / Interview:**
 - a) Candidate's original copy of Admit card for the written test held on 08.07.2021.
 - b) Date of birth/Proof of age.
 - c) Original certificates of educational qualifications and technical qualifications from recognized University/Institute (supported by appropriate mark sheets) starting from SSC / X standard onwards.
 - d) SC/ST certificate issued by an Authority duly authorized to issue such Certificate in the prescribed format
 - e) OBC certificate issued by an Authorized Authority in the prescribed format with Non-Creamy layer certificate as on 10.01.2020.
 - f) Candidates claiming reservation under Economically Weaker Section (EWS) are required to produce Income and Asset certificate issued by the Competent Authority in the prescribed format as available in NFC website (posted along with advertisement issued on 21.12.2019).
 - g) 'No Objection Certificate' from the Employer in case the candidate is working under Central/State Government, Public Sector Undertakings/Autonomous Bodies.
 - h) Proof to the effect that the candidate has been affected by 1984 riots (if claiming age relaxation).
 - i) Certificate regarding domiciled in Kashmir Division from 01.01.1980 to 31.12.1989 (if claiming age relaxation for Kashmir division).
 - j) **Candidates should bring with them one set of Xerox copies of all the above documents duly self-attested.**
