- ii. Certificates of educational qualification starting from SSC/X standard onwards;
- iii. Mark sheets of all Semesters/years;
- iv. Resume clearly bringing out the description of work and experience.
- v. Experience certificate duly issued by the employer bringing out clearly the nature / field of experience, organization in which service was rendered. Please note that copies of offer of appointment / pay slips will not be considered as proof of experience;
- vi. Community certificate issued by the Competent Authority in respect of candidates belonging to SC/ST/OBC (if applicable)
- vii. No objection certificate from the present employer in case of those candidates who are working under Central/State Government, Public sector undertakings and Autonomous bodies;

**Note:** Candidates who fail to produce the above documents will not be allowed to attend Interview.
