2. The list of candidates **Screened in (Annexure- I & II) and Screened out (Annexure- III)** for the post of Scientific Officer 'C' (General Duty Medical Officer) are enclosed.

3. Admit cards will be sent to the Screened-in candidates to the email ID as mentioned in their respective Application forms. No separate communication will be sent in this regard.

4. Important Instructions for Screened-In candidates:

- i. Roll number as mentioned in the **Annexure-I & Annexure-II** against each candidate has to be quoted wherever required and may be preserved for future correspondence.
- ii. Candidates are advised to locate the Test centre in advance and reach the Venue by the reporting time mentioned above.
- iii. Candidates are informed to bring the Admit card to the Venue duly affixing recent Photograph with self attestation and are advised to retain a copy of the Admit card.
- iv. Candidates have to bring all the original certificates of qualification starting from SSC/X onwards along with experience certificates, as given below:
 - (1) SSC / Xth Mark List
 - (2) HSC / XIIth / Intermediate Mark List
 - (3) MBBS Mark List and Degree Certificate
 - (4) Medical Council Registration Certificate having validity.
 - (5) OBC Certificate (from candidate applied for post in NFC, Hyderabad)
 - (6) Experience Certificate (s).
 - (7) Screen Test Pass Certificate (for candidates who studied MBBS outside India)
 - (8) Ex-Servicemen Certificate (for candidates w.r.t. age relaxation)
 - (9) No Objection Certificate (for candidates who are working as per bond or those working in Government / PSU / Autonomous Bodies)
 - (10) Valid Photo Identity Proof, like, Passport, Driving Licence, Aadhar Card, PAN Card, Voter I.D. Card, etc.
 - (11) SC/ST Certificate for those outstation candidates seeking reimbursement of TA.
 - (12) Any other document mentioned / required as a proof to verify the data in the application
- v. Candidates are required to bring original of any one of the valid Photo Identity Proof viz., Passport, Driving Licence, Aadhar Card, Voter Identity Card or PAN Card etc as ID proof.
- vi. Candidates may note that they are provisionally called for the selection process. At any stage of recruitment, Nuclear Fuel Complex (NFC) reserves the right to make the candidature ineligible if any information furnished by the candidate in the application is found to be incorrect or found ineligible with regard to requirements notified in the said advertisement for the post. In such a case, decision of NFC will be final.

- vii. Outstation SC/ST candidates are eligible for reimbursement of TA equivalent to second class Train Fare or bus fare by the shortest route from their place of residence for attending above selection process. The candidates are required to produce copy of (i) certificate of unemployment from MP/MLA/Gazetted Officer of the place where the candidate normally resides, (ii) original travel ticket/proof of travel and (iii) caste certificate. The TA amount as admissible will be remitted into the Bank account of the candidate separately. No reimbursement will be made in case of non-submission of any of the documents.
- viii. Candidates may note that in case of failure to bring original certificates for verification or any discrepancy noted in the certificates, such candidates will not be allowed for attending Personal Interview.
- ix. SC/ST candidates who attend Personal Interview after certificate verification are only eligible for TA as per norms.
- x. No request for change of Venue / Date / Time will be entertained.
- xi. Final results would be placed on NFC website – www.nfc.gov.in on a subsequent date.
- xii. The candidates are required to visit the NFC website for the results and other details from time to time as no Postal communication will be sent in this regard.
- xiii. Canvassing in any form will be a disqualification.
- xiv. All other general conditions as mentioned in the Advt. No.: NFC/03/2022 and Admit card will continue to apply.
