If, it is found that any candidate is not fulfilling the recruitment rules/norms, his candidature is liable to be terminated / cancelled at any point of time.

5. Appointment of candidates will be subject to availability of vacancies and other related Govt. Orders viz. receipt of satisfactory/clear verification of Character & Antecedent Reports, medical fitness certificate (issued by Medical Officers), production of original documents such as educational qualification certificates, No Objection Certificate and verification of Caste Certificate / Non-Creamy-layer Certificate, Caste validity certificate etc. wherever applicable.

6. Candidates on their appointment are liable to serve in any of the Constituent Units of the Department of Atomic Energy located in any part of India.

7. The wait list will be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the Select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time.
